### 4. FIRST AID MEASURES

#### Description of necessary measures

**Inhalation:** If inhaled, immediately remove the affected person to fresh air.  
**Skin contact:** First aid measures not required. Cosmetic product and therefore not necessary.

#### Special protective equipment and precautions for fire-fighters
